 - Would like another youth member
- Thinking about Adult Faith Formation
- Thinking about organizing members with Jewish background through the Seder
- Would like to start parent book group
- There is a need in the congregation for getting together people with special needs and their caregivers has some ideas

Report from BOT – Laurel

- · Amanda gave report (see above)
- Budget priorities informed the discussion about the budget goal
 - o BOT would like to return to a full-time membership coordinator; budget includes half of the amount needed to get there.
 - \$635,000 is budget goal for next year
- Sanctuary congregations lengthy discussion

Financial

- Review January expenditures
 - No issues raised.
 - Judy she will be making a proposal to the finance committee that if there is unspent money in major building expenses, that it be moved into the Board of Endowment building reserve fund so that it can be spent as necessary after the fiscal year ends.
- Multi-year forecast
 - The long-term forecast is going to the BOT for discussion at their next meeting
 - o If we can increase pledges by 4% and expenses by 3% per year, we will keep pace; this would not, however, support a FT membership coordinator.
- Venmo update for paying youth
 - Postponed discussion due to Sharon's absence
 - Discussion of how youth are paid no taxes or Social Security withheld
 - Youth paid \$15 per day (Sunday) that they work
 - Question about whether youth have work permits
 - Karen Davis suggested regular communication with youth and parents as reminder to cash checks
- · Calculation of UUA dues will wait for discussion until detailed plan is made

Building and grounds FY'21 budget – Laurel

- Laurel handed out copies of draft budget for FY 21
- Laurel discussed the rationale for budget figures. Priorities for major maintenance include: replacing one section of the slate roof; restoring two stained-glass windows in the Sanctuary; and painting and floor recoating in the Parish Hall.

 - Decision will move the 2 paintings from the hall wall into the chapel;
 legacy committee can use that space
- Hearing assistance signs & notice in order of service
 - Signs are paper, taped in place

- o Discussion of whether signs should be made more permanent
- $_{\odot}\,$ Decision to leave the paper signs up a bit longer and see if people see them and request hearing device
- Sound/projection in Parish Hall
 - Jud and Bob are updating the sound system in the Parish Hall
 - Projector could be permanently installed to project on screen that is on stage – being worked on
