Financial

- · Worship: summer services budget
 - Lois Shapiro has been providing music for summer services; has been paid less than what she is paid for other services.

• Laurel moved to pay Lois \$200 per summer service; Eric seconded. Laurel questioned whether volunteers had provided music in the summer in the past, or could in the future; discussion. Vote - unanimous approval, motion passed.

- · Keeping track of specific pledge updates
 - Question about whether there is system for this
 - Karen will check
- · Use on on-line platform for plate collections Sharon

• Could do via Realm; there is a cost associated with it – transaction and credit card cost

• Might be best to put something in newsletter and ask for contributions

• Apparently many people have administrative privileges on Realm; probably should review. Access is modular.

• Further discussion of how to accomplish plate collections – Jud will contact Zoom to see if they have a mechanism for that.

• Erin – there is a question about whether there can or should be special collections next year; will need to be addressed shortly.

Update: Building closure

- When to make decision on date to re-open
 - Eric suggested making this decision later in the summer
 - Jud need to consider who or what needs advance notice
 - Erin should consider the moral aspect of re-opening e.g., should choir

be singing; will it be safe for all congregants? Can everyone who wishes attend with social distancing restrictions?

- Decision was to postpone making a decision until later in the summer
- The Ops Council will continue to meet over the summer
- · Pine Village
 - Laurel the governor announced that day care could open last week if a center's plan was approved,, but regulations for the plan were not announced until this week.

• Pine Village's plan is for staff to start June on 22^{n} , children on June 29^{h} , pending plan approval

- Laurel suggested that staff not be in building during day care hours
- Long discussion about options for staff and Pine Village staff and children to enter, exit, and use the building
- Pine Village will be contacted and given options for entrance and exit

• The stained glass window over the balcony contains image of a slave. At the time it was installed it was meant to be an honor. (Photos of window and history about its meaning and installation were emailed prior to this meeting.)

• Discussion about the meaning of window and what to do about it.

• Erin suggested contacting the racial justice ministry and get their opinion; this option was approved.

• Do we need BOT/Ops rep at summer services? After discussion, no decision was reached; Susan will check with Chris Krebs.
