Thanked the group and staff for their work over the past year

Financial - no updates

B & G Issues - Laurel

- Status of air purification upgrades
- o Contractor thinks he will be starting next week

- o There will not be outside air brought in; recirculated air will undergo ultraviolet light treatment to kill microorganisms
- o Hopefully will be done by September, but not guaranteed
- o Susan suggested that Laurel start writing up information for the congregation on what is being done for air purification
- Proposal for building occupancy information Newton requirement
- o Code consultant needs to be hired at a cost of \$5,447
- o Another \$6-9,000 for LDA review of building
- o Money to come out of Major Maintenance budget line, will not be an overrun of budgeted amount.
- o Laurel moves that we (Chris for BOT) sign a contract with LDA associates for \$6,000-9,000 for the review of the building plans and \$5,447 for Code Red (code consultant). Karen seconds, unanimous approval, motion passes.
- Rental questions: AA group; Sept. wedding rental. Everyone has been told that the building will not be rented until ventilation and building purification are completed. The previously approved August wedding will not be taking place.
- Laurel, in previous years, has had a concert at her home for services auction. People have already purchased attendance at the concert from the last services auction. She would like to have it in the sanctuary so that people can be socially distanced, either late August or September. Discussion of the issue consensus is that September is better, assuming that the building has been re-opened.

Reopening FUUSN building

- Considerations: when and how to re-open
- o Susan need to come up questions that need answering in order to come up with a decision. The decision will be made at the July Ops Council meeting.
- o Discussion
- § Jud his thinking is that we should assume a September re-opening, pending any new issues.
- § Demi wondered if some immune-compromised members could be contacted to see what would work for them.
- § Laurel how do parents of children under 12 feel about them coming back
- § Amanda they are planning for an in-person return, allowing a lot to take place outdoors or in large spaces, e.g., upstairs Head Start room. Most children have been back in school for some time, and are ready to meet in person. Children are masked while in schools unless less than 3 years old. Suggested having some informal gatherings over the summer to get people used to being together.

- § Question about whether congregants could be socially distanced in the sanctuary; most thought not, based upon the usual number of attendees at services. Another idea was to space some congregants (e.g., one-half of sanctuary), others not.
- § What about the choir? They would need to be distanced.
- § Will distancing even be necessary by September?
- § Need to decide what is needed in September
- Streaming of service
- How will sanctuary be opened?
- § Erin the first September service will be Sept. 12; wondered if we could find a place to hold service and coffee hour outdoors.
- § Summer get-togethers
- It was decided to have July and August picnic/events so that people could get together
- Pat Rohan to do a July membership picnic
- Ask Julia W and Saul L to organize an August picnic with Amanda
 - Hybrid services
 - o Jud will check on what is needed for streaming. equipment and personnel.
 - Needs to know what is needed for the Sept. 12 service
 - o Copyright issues for music and sermon Susan will look into, speak to Erin.
